## Care and Cleaning

**Wash:** Machine washable up to a maximum temperature of 50 °C.

**Dry:** Wipe with a cloth or dry at room temperature.

## Attention

**WAYLITE** resists several washings at 50 °C in washing machine. It is not recommended the use of bleaching agents during washing machine cycles at 50 °C.

To keep your shoes new and beautiful for much longer, it is essential to follow some recommendations: Avoid getting your shoes wet, but in case this occurs, never place them in the sun. Let them dry in the shade and also away from any other source of heat, because heat damages the materials, the colour and the texture. A soft cloth is the main ally of this type of shoe and its cleaning should be done weekly or whenever necessary.
